Members of the public are hereby informed that the Monetary Policy Committee of the Bank of Mauritius has been constituted as follows:

1. Dr Rama Krishna SITHANEN, G.C.S.K. (Governor and Chairperson, ex-officio)

Dr Sithanen is an economist with over 46 years of experience. He has held significant roles in both the public and private sectors, including Minister of Finance and Vice Prime Minister, where he introduced key economic reforms.

Dr Sithanen holds a BSc Economics (with First Class Honours) and an MSc Economics (with a Mark of Distinction) from the London School of Economics and Political Science. He also has a PhD in Political Science from Brunel University, London, UK.

2. Mr Rajeev HASNAH (First Deputy Governor, ex-officio)

Mr Hasnah is an economist and CFA Charterholder with extensive experience in investment management, corporate finance, law enforcement and economic diplomacy.

He holds a MSc in Economics and Finance from Warwick Business School and a BSc in the same field from the University of Mauritius and is a Chartered Financial Analyst.
