

International Investment Position¹ as at end-March 2024: Preliminary estimates

- Preliminary estimates of the International Investment Position (IIP) of Mauritius as at end-March 2024 indicate a net foreign asset position of Rs1,949 billion (equivalent to USD41.7 billion). Claims on non-residents are estimated at Rs26,875 billion (equivalent to USD576 billion) while liabilities to non-residents are estimated at Rs24,926 billion (equivalent to USD534 billion).
- The net foreign asset position of the GBC sector stood at Rs1,391 billion (equivalent to USD29.8 billion) as at end-March 2024. GBCs' claims on non-residents amounted to Rs25,033 billion (equivalent to USD536.3 billion) while their liabilities to non-residents stood at Rs23,642 billion (equivalent to USD506.5 billion).
- The net foreign asset position of the non-GBC sector stood at Rs558 billion (equivalent to USD12.0 billion) as at end-March 2024. Non-GBC residents' claims on non-residents amounted to Rs1,842 billion (equivalent to USD39.5 billion) while their liabilities to non-residents totalled Rs1,284 billion (equivalent to USD27.5 billion).
- 4. Among the non-GBC sector, the net IIP of banks and non-bank deposit taking institutions rose from Rs497 billion (equivalent to USD11.2 billion) to Rs544 billion (equivalent to USD11.6 billion). This was largely driven by increases in banks' stock of foreign currency deposits abroad and loans to non-residents, which more than offset the rise in their stock of external liabilities in terms of foreign currency deposits and loans from non-residents. The central bank's reserve assets rose to Rs337.3 billion (equivalent to USD7.2 billion) over the same period.

Table 1 summarises the foreign asset and liability position of Mauritius by functional categories as at end-March 2024.
