

Monetary Developments: May 2020

Broad Money Liabilities (BML) rose by Rs5.8 billion or 0.9 per cent, from Rs634.9 billion as at end-April 2020 to Rs640.6 billion as at end-May 2020, mostly reflecting the increase in deposit liabilities and currency with public. Year-on-year (y-o-y), BML grew by 13.5 per cent in May 2020, up from 12.3 per cent in April 2020. All the components of BML, with the exception of debt securities, contributed to the y-o-y increase.

Over the month, net foreign assets (NFA) of depository corporations rose by Rs0.2 billion, from Rs674.0 billion as at end-April 2020 to Rs674.2 billion as at end-May 2020. Y-o-y, NFA grew by 14.8 per cent in May 2020, higher compared to the growth of 12.0 per cent registered in April 2020.

Claims on other sectors (excluding financial derivatives) stood virtually unchanged at Rs502.6 billion in May 2020. Y-o-y, claims on other sectors (excluding financial derivatives) went up by 6.6 per cent in May 2020, lower than the increase of 7.2 per cent in the previous month. Net claims on central government increased by Rs12.3 billion, or by 12.0 per cent to Rs114.7 billion in May 2020.
