



## *Central Bank Survey: End-June 2015*

The monetary base went up by Rs790 million or 1.1 per cent, from Rs70,804 million at end-May 2015 to Rs71,594 million at end-June 2015 as against a decrease of 5.8 per cent registered between end-April 2015 and end-May 2015. The rise in monetary base reflected mainly increase in Liabilities to Other Depository Corporations.

The annual growth rate of monetary base stood at 15.2 per cent in June 2015, up from 13.1 per cent in May 2015.

On the sources side of the monetary base, net foreign assets of the Bank went up by Rs453 million or 0.3 per cent, from Rs138,175 million at end-May 2015 to Rs138,628 million at end-June 2015. Net Claims on Central Government increased by Rs1,164 million, from negative Rs22,878 million at end-May 2015 to negative Rs21,715 million at end-June 2015.
